- 5. The hours prescribed for training/demonstrations/tutorials, project work must be as per the rules prescribed by the government.
- 6. According to the posts sanctioned to the college, the reservation point list must be validated by the prescribed authority as per the prevailing reservation policy of the government.
- 7. In case of reduction in the number of students in the next academic year or if the workload of the aided department decreases due to other reasons, the backlog of posts will be reduced.
- 8. As per the prevailing policy of the Government as per permissible post no recruitment shall be made without the prior permission of the Government. If irregularity is found in the appointments to such sanctioned post, the same shall be disallowed in the determination of grant. The management and the college will be responsible for the irregular appointment.
- 9. The posts are sanctioned based on the grant-eligible workload of the college. For recruitment to sanctioned posts, it is necessary to independently submit a proposal and obtain a no-objection certificate as per the prevailing policy and procedure of the Government.


